Meeting Notes

Reporting on External, Project-Related Discussions

- Mark Project 175, Rural Disadvantaged Community Partnership Project. Left message for Dave Harvey at RCAC.
- Cathy Project 116, City of San Diego Mt. Abernathy Green Street Project and Project 92, Bannock Avenue Neighborhood Streetscape Improvements & Bacteria Treatment for Tecolote Creek Watershed Protection. City can combine projects.
- Cathy Projects 159/186, Phase I-Chollas Creek Integration Project. No overlap with City stormwater efforts (Ruth/David Wells), but supportive of the project. Jacobs Center would need own stream restoration permits.
- Sheri Project 37, San Diego County Beaches Wet Weather Contamination Assessment. County would not change current management practices (72 hour advisory) based on project data.

- Kirk Project 181, Integrated Flood Control and Water Quality Protection Program. Work plan involves 1) CMP to be removed and replaced with concrete and 2) Infiltration strips to be placed within the creek. BMP opportunities.
- Sheri Project 187, Implementing Nutrient Management in the Santa Margarita River Watershed Phase I. Phase 1 of the project is \$600K; Phase 2 is \$2.2M.
- Gabe Project 26, San Diego Regional Water Quality Assessment and Outreach Project and Project 37, San Diego County Beaches Wet Weather Contamination Assessment. Projects can be combined. Though Project 37 costs can't be reduced.
- Carlos (guest from SDCWA) Projects 198/200, Sustainable Landscapes Program.
 - Integration talks occurred; City and County have agreed to partner. SDCWA agrees to take on administrative burden for conservation projects.
 - Relationship with Prop 50 grant contract -- 3 of 6 tasks begun; 3 of 6 tasks to be rescoped. No billing to DWR so far; estimate \$500K spent.

Discussion of Preliminary Project Package

Workgroup continued discussion of the preliminary project package.

Final Project Package

Workgroup reviewed the preliminary project package against the Proposal-Level Criteria established by the RAC and identified a final project package.

- Agreement to levy 3% Proposal Administration cost (to cover SDCWA expenses) across the package.
