#### **Roundtable Successes**

- Continued building relationship with DWR and advocating for IRWM
  - Provided input into DWR grant guidelines
  - Developed outreach materials and website
- Coordinated with other groups (e.g. ACWA, CASQA) and water resource news (Maven's Notebook)
- Completed member surveys to identify strengths, weaknesses, and successes
- Discussing how to move IRWM forward under Water Resilience Portfolio; submitted comments

#### State Feedback on IRWM

- State shifting focus to "resilience"
- IRWM should highlight how it can support regional resiliency
  - Key is coordinating with other entities working in regional, integrated space

What is "resilience"?

#### State Feedback on IRWM, cont.

- Lack of widespread understanding of benefits
  - · Need metrics for success
  - · Highlight success stories
- Funding not allocated to align with needs and benefits
  - Adjust formula to account for more than just population
- Benefit of IRWM lies in collaboration and partnerships

#### **Strengths and Weakness of IRWM**

Attendees identified what was and was not working well in IRWM

#### **IRWM** Benefits

- Collaboration, integration
- · Inclusivity, representation
- Local/regional needs, solutions
- · Brings funding into regions
- Supports projects that otherwise might not occur
- Relationship with State

#### **IRWM Challenges**

- State doesn't prioritize/elevate IRWM
- PR/image issues
- Some key groups missing
- Lack of integration with other programs
- Challenging funding process
- Uncertain future



#### **Future of IRWM Funding**

- Future IRWM funding is uncertain
- 4 water bonds in development:
  - SB 45 \$4.1B
  - AB 352 \$3.9B
  - AB 1298 funding TBD
  - Caves initiative \$7.8B
- None currently include IRWM funding
- Current remaining IRWM grant funding Prop 1 Round 2 (2021)
  - ~\$16M for San Diego Region

#### **Water Resilience Portfolio**

- Executive Order N-10-19
  - Prepare a water resilience portfolio that meets the needs of California's communities, economy, and environment
- Multiple listening sessions across state
  - SDIRWM briefing held at August RAC meeting
- SDIRWM submitted comment letter highlighting role IRWM can play in regional resiliency

#### **Status of Water Resilience Portfolio**

- Draft in Governor's office (as of Thanksgiving week)
- Plan will be actionable, unlike Water Plan Update
- State working on how to fund initiatives to jumpstart the portfolio
  - Expect to see in Governor's budget
  - · Will probably be included in water bond

#### **Prop 84-Round 3 Funding Reallocation**

- Prop 84-Round 3 funded 7 projects in July 2014,
   5 of which are still in progress
- City of San Diego's Water Use Reduction Project received \$699,250 to fund financial incentives to residential and commercial customers to install pressure-reducing valves
  - Less interest in rebate program than anticipated
  - Concerned about meeting grant agreement deadlines, City elected to return remaining funds

#### **Funding Reallocation Policy**

- City's decision triggered SDIRWM Program's Funding Reallocation Policy
- Policy directs RWMG to either:
  - Transfer project's remaining grant funding to one or more projects within the same grant package that are still active and, ideally, offer similar benefits
  - 2. Decline to reallocate grant funds due to population served, timing, etc.

#### **Prop 84-Round 3 Funding Reallocation**

- 4 projects are still under way, and therefore eligible for reallocation of remaining funds
  - All 4 projects submitted a request for either some or all of the funds
  - Project must provide <u>additional</u> benefits to be eligible for grant fund reallocation
- Remaining Project Selection Workgroup (PSW) members from Round 3 reconvened on Nov. 22

#### **Prop 84-Round 3 Funding Reallocation**

- PSW allocated remaining funds to 2 projects:
  - Rincon Customer-Driven Demand Management
     Program (Rincon del Diablo Municipal Water District)
     41% of available funds
  - Regional Demand Management Program Expansion (San Diego County Water Authority) – 59% of available funds
- 3% of total grant award allocated to grant administration



#### **DWR Feedback on Proposed Projects**

- RWMG reported on DWR pre-application workshop at October RAC meeting
  - Encouraged LPS to scale projects to a more manageable project size (\$), despite decreased benefits
  - Had difficulty clearly understanding more complex, multi-benefit projects
  - · Concerned some project elements not eligible
- RWMG adjusted application following multiple conversations with DWR and LPS

#### **Prop 1-Round 1 Application Updates**

- To address "manageable project size" issue:
  - · Scaled projects to include fewer components
  - Generally delivers same amount of benefits
- To address "complex projects" issue:
  - 2 North County projects separated into 3 projects
  - Simplified Water Authority project
- To address "eligibility" issues:
  - Removed the North County pathogen studies & engineering analysis
  - Reframed Water Authority project elements



## **Prop 1-Round 1 Application Benefits**

- Projects will provide the following benefits:
  - Offset imported water by 38,000 AFY
  - Reduce pollutant loading by 7,000 lbs/yr
  - Treat and capture stormwater: 54 AFY in total
  - Reduce greenhouse gas emissions by 29,000 MT CO<sub>2</sub>e
- DWR does not record benefits from studies/decision support tools

#### **Prop 1-Round 1 Application Summary**

- PSW approved the updates on Nov. 21
- Seeking consensus approval from the RAC
- Original "alternates" defined by the PSW in the event of project removal include:
  - 1) fully funding National City, and then
  - 2) fully funding SDCWA Regional Conservation
- No projects have been removed from those selected, they have been revised and refined to meet DWR criteria
