### **State Updates**

### Proposition 4

Safe Drinking Water, Wildfire Prevention, Drought Preparedness, and Clean Air Bond Act of 2024

Priority is to finance projects for safe drinking water, drought, flood, and water resilience, wildfire and forest resilience, coastal resilience, extreme heat mitigation, biodiversity and nature-based climate solutions, climate-smart, sustainable, and resilient farms, ranches, and working lands, park creation and outdoor access, and clean air programs.

IRWM is allotted \$100 million.

DWR shall update and revise the guides for IRWM Program to address impacts associated with climate risk

# Future of San Diego IRWM - Triggers for Change



### **Designated IRWM Funding**

- State funding may not be available in the future
- If Prop 4 passes, limited funding is available and likely for only one round



### IRWM Plan Compliance

- No longer always required for state eligibility for non-IRWM grants
- Prop 4 may require an IRWM Plan Update



### **State Priorities**

- Shifting towards to a watershed scope approach
- California Water Plan update does not state any IRWM specifics



# RAC Evolution



- Retain advisory role to the RWMG and SDIRWM Program
- Continue to meet quarterly, focusing on fostering collaboration and information sharing on cross-cutting water management issues
- Shift to informal membership structure, removing formal designated RAC seats and broadening participation, eliminating the need for RAC member terms
- Simplify the caucus structure and allow participants to self-select their caucus
- Workgroups continue on ad-hoc basis, open to volunteers

# RAC Membership Term Turnover 🧽



- The 2021-2024 RAC term is ending, necessitating a membership turnover, unless the RAC structure changes
- RWMG is still finalizing details to implement the proposed actions
- RWMG proposes to extend expiring terms for up to one year to ensure smooth transition, update processes, and revise policies

- Streamlined project selection process

# **Summary of Projects**

### San Pasqual Duro Community Waterline Project

- Construct a new water transmission pipeline that will connect Valley Center Municipal Water District's distribution pipeline to San Pasqual's existing distribution system
- Provide 6 AFY of safe water supply to the Duro Community

### Ballard Well Connection and Transmission Pipeline

- Acquire and connect a recently drilled and equipped well (Ballard Well) to LMOSMWC's water system through 5,000 feet of pipeline
- Provide 4.6 AFY of safe water supply to Lake Morena residents

### The Acres Water Consolidation Project – Phase 1

- Construct 5,000 feet of 8-inch water main
- Provide approximately 44 AFY of safe water supply to the residents of the Acres community

### R-2 Reservoir Rehabilitation Project

- Rehabilitate the existing R-2 potable water reservoir
- Provide approximately 878 AFY of safe water supply to El Toro District's disadvantaged communities

# **Project Challenges**

LMOSMWC halted work on the Ballard Well Connection and Transmission Pipeline Project due to difficulties in acquiring the Ballard well and surrounding project land

- Original grant award: \$1,730,000 (with advance funding)
- No viable alternate scopes of work identified
- Amount available for reallocation: estimated \$1,680,749
- Amendment request to DWR due December 2024
- SDIRWM Reallocation Policy has been triggered to reallocate unused grant funds

### **IRWM Funding Reallocation Policy**

- Funding Reallocation: when projects withdraw, are incomplete or change substantially
- Submission Requirements: Eligible project sponsors submit work proposals with funding justification and budget requests
- Evaluation Process: Project Selection Workgroup (PSW) reconvenes to assess scope feasibility, benefits and reallocation amounts, and makes final recommendations to RWMG
- DWR Guidelines: Reallocated funds must support open projects in the same grant agreement, and must provide similar benefit type as withdrawn project
- Current Opportunity: Two active projects have been invited to request, and one request from Ramona MWD was received

- To ensure timely amendment process and fund usage, RWMG is to reallocate funds after RAC meeting
- Final RWMG recommendation will be emailed to the RAC
